Remove as much surface debris and organic growths as possible by scraping and brushing. For maximum biocidal effectiveness use on dry substrates. Apply by brush, roller or spray at a rate of 5-10m² per litre depending upon the porosity of the substrate. Scrub treated areas with an appropriate brush and leave for up to 20 mins but do not allow to dry when used principally as a cleaner. If treating wood before re-coating, leave for 24 hours to maximise biocidal effect. Rinse / wipe down with clean water to remove residues and dead growth then allow to dry before continuing with any subsequent treatment. High pressure jet-washing not recommended. It maybe necessary to repeat the process for heavily contaminated areas. Only use when the surface and ambient temperature is above 5 Celsius, Store at temperatures ideally above freezing and always replace the cap. Knockout Mould & Mildew Cleaner is not a bleach so will not remove all staining from surfaces. Contains less than 5% cationic and non-ionic surfactants.
