

KNOCKOUT Spirits of Salt

PLEASE READ ALL INSTRUCTIONS BEFORE USE. DO NOT MIX WITH OTHER CHEMICALS. USE IN A WELL VENTILATED AREA. IF THE AREA IS NOT WELL VENTILATED A POSSIBLE BUILD UP OF FUMES WILL OCCUR AND CAUSE CHROME FITTINGS AND OTHER METALS TO CORRODE. NEVER USE A PLUNGER WITH THIS PRODUCT.

For blockages caused by limescale, follow instructions below. For other blockages, we would recommend using Knockout Drains, Toilets & Urinals or Knockout Professional Toilet & Drain Cleaner.

Do not use any product in combination with the contents of this bottle. DESCALES TOILETS, removes stubborn stains and hard water scale around rim and below waterline. After treatment, flush toilet thoroughly. NOT SUITABLE FOR WASH BASINS, BATHS, SHOWERS OR KITCHEN SINKS.

HANDLING INSTRUCTIONS

Wear appropriate personal protective equipment (PPE) such as chemical resistant gloves, overalls and eye/face protection to protect against splashes. If in doubt, speak to your PPE supplier and show them this label/product, or call us for further advice. Avoid breathing fumes. Spirits of Salt is corrosive to most common metals including enamelled and stainless steel surfaces. Also avoid direct contact with chrome fittings such as plug holes, toilet seat fittings etc.

For most applications use about 500ml. Allow to work for 20-30 minutes only, then wash down with copious amounts of water. For some applications, a plastic funnel may be the most effective way of introducing Spirits of Salt direct to the point of treatment. Not suitable for wash basins, baths, showers or kitchen sinks.

FOR EXTERIOR USE: Removes excess cement from new facing bricks. If using on coloured stone, test for colour fastness first. Do not use on tarmac/adam or marble/limestone surfaces. Rinse treated areas thoroughly with water afterwards.

TIP Use sodium bicarbonate to neutralise any spills.
